### SECTION 6 – Fees

Membership Registration:

There is no Membership Registration Fee.

British Gymnastics Annual Membership Fee:

The British Gymnastic Annual Membership Fee is payable on joining Clevedon Gymnastics and Leisure Club and annually thereafter, it is non-returnable. It encompasses the appropriate British Gymnastics membership fee and insurance for your child and the club. The fee for 2010/2011 for a recreational gymnast is £15.00 and a cheque should be made payable to British Gymnastics for this amount. The insurance is renewable annually in October. The amount charged by British Gymnastics varies each year so please check the current rate.

Tuition Fees:

These fees are payable before the commencement of each gymnastic term (normally a 9 week period) and cover the class fees for your child. The current fee for a one hour lesson is £4.00

### SECTION 7 – Equity Policy

Clevedon Gymnastic and Leisure Club is committed to exemplary standards of conduct through the principles of equity and good moral and ethical frameworks. The club will encourage individuals from all communities to become involved at all levels of participation, coaching, judging and officiating.

All persons must respect the rights, dignity and worth of every individual. All individuals must be treated fairly and equally regardless of gender, age, ethnic origin, religion or political persuasion or disability. Equity must permeate throughout strategic and development plans. An equal professional service will be provided for all participants and discrimination through race, gender or disability will not be tolerated. Sexual harassment, racial harassment and discrimination will be prohibited.

### SECTION 8 – Jewellery/Body Piercing Policy

It is a British Gymnastics Policy that jewellery and adornments worn in body piercing are inappropriate for safe participation in gymnastics and trampolining. This policy applies to all members and coaches in training and at events. Anyone with body adornments or jewellery must remove them to reduce the risk of injury to themselves, coaches and others. Anyone refusing to remove body adornments or jewellery will not be allowed to participate. We strongly recommend that accompanying parents/carers/siblings also remove jewellery when participating to avoid injury to themselves and their children and to avoid damaging equipment.

### SECTION 9 – Codes of Conduct

We draw your attention to the following points:-

- Always ensure your child is dressed appropriately for the activity: Leotard for girls and shorts and t-shirt for the boys are the preferred clothing. Hooded tops, jeans and clothing with toggles, zips, ties and buttons on the outside are not appropriate. Long hair must be tied back.
- Always pick up and drop off children promptly for their class. Children will not be allowed to leave at the end of the class unaccompanied.
- Camera/video equipment (including mobile phones) may only be used by people who have registered themselves and their equipment with the club in advance and only in accordance with the club's Photography and Child Protection Policies.
- Parents must remain in the foyer – we welcome questions but we request that they are raised either at the start or end of a class and not during as this can distract the gymnasts and coaches.

- Mobile phones may not be used during classes, except in an emergency.
- Members, parents and spectators are expected to maintain a good standard of behaviour - bad behaviour, abuse, swearing and bullying of any sort will not be tolerated
- Intimidation or disparagement of the knowledge, performance or abilities of others are also inappropriate

### **SECTION 10 – Agreement to Participate**

Gymnastics is an active sport and so has an inherent risk of injury. Although Clevedon Gymnastic and Leisure Club will endeavour to minimise any risk, accidents may still happen. It is incumbent on all participants to make themselves aware of and abide by the safety rules, policies and codes of conduct at all times. Clevedon Gymnastic and Leisure Club does not accept responsibility for any injury sustained as a result of the injured party acting contrary to instruction, whether express or implied.

Teaching gymnastics safely inevitably requires contact between the child and the coach. Working with children can require additional contact, especially when dealing with shy, injured, fearful or difficult children. While Child Protection will always be paramount and unnecessary contact will always be avoided, coaches also have a duty to provide for the particular emotional needs of such young children.
